SECRETARY'S MINUTES: Motion to approve by Marlowe, seconded by Ron; m/c.

PROGRAM: Damjana Brajovik, spoke about her home country, Montenegro, one of the Balkan nations across the Adriatic Sea from Italy. She is the 10th foreign exchange student in eight years who has stayed with Dave and Jan Jastram. Damjana is from the capital city of Podgorica, where they use Euros and speak several languages. She began to learn English at the age of five, and now also speaks Russian, Serbian, and Korean. Duly Noted: Tom L. asked that it be noted that Grandpa Wayne "babysat" Augustus during the program.
